Type of data processed

The data controller processes personal data shared in the course of the purchase/supply relationship.

Purpose of personal data processing

Personal data will only be processed when necessary (Art. 9(2) GDPR) to fulfil or implement the supply or purchase contract.

Modalities of processing

The processing of personal data is carried out by means of computer tools or paper documents, by employees expressly authorised to process them and appropriately instructed in order to guarantee the confidentiality of the processed data and to prevent the loss, destruction, unauthorised access or unauthorised processing of the same data.

Retention of personal data

We would like to inform you that, in compliance with the principles of lawfulness, purpose limitation and data minimisation, pursuant to Article 5 of the GDPR, personal data will be stored for a period of time no longer than is necessary for the purposes for which they were collected or subsequently processed and for a maximum period of 10 years from the termination of the contractual relation as provided by the applicable laws on limitation of rights or regulations and except in the event of the need to protect rights before the competent Jurisdictions.

- employees and collaborators of the Data Controller, expressly authorised to process your personal data;
- other parties such as clients of the Controller, however, within the limits of the purposes indicated in this notice.

The subjects to whom your personal data may be communicated are: internal employees of the Data Controller or the Data Processor authorised to process your personal data. Furthermore, your data may be processed for communications to national and foreign public/private entities that are clients of the Data Controller, or other public administrations when such communications are required by law (e.g. regarding subcontracting), limited to the above-mentioned purposes.

Rights of the data subject

As a data subject, you have the right to obtain confirmation from the Controller as to whether or not personal data concerning you is being processed. You will also be able to exercise your rights to update, rectify, supplement, portability and erasure of your personal data pursuant to Articles 16 to 22 of the GDPR. You may also appeal to the Data Protection Authority in the event of a violation of your rights.
